In the event the race is delayed or cancelled for any reason, including but not limited to emergency or local or national disaster,acts of God or the elements (including without limitation, rain, snow, sleet, hail) or any other cause beyond the control of the Mattoon Santa Chase event, there shall be no refund. I acknowledge that all entry fees paid are non-refundable and non-transferable. The undersigned grants permission to sponsors and/or agents authorized by them to use any photos, video tapes, motion pictures, or any other record of this event for any purpose. I hereby consent to receive medical treatment, which my be deemed advisable in the event of injury, accident and/or illness during this event .
